In 2009 he became a lecturer at the Department of Administrative Law and Administrative Science at the Faculty of Law of the University of West Bohemia in Plzeň. Since 2011 he has held the same position at the Faculty of Law of Charles University in Prague, leading a seminar on the right to information and a legislation course. He is a lecturer at the Judicial Academy. He publishes and lectures on civil and administrative law, information technologies, and legislation. František is a co-author of the large commentary to the new Civil Code, published by Leges, and popular comparison tables showing changes between the former and the new private legislation. He manages the firm's training ACADEMY.
