office engaged in designing bridge structures. In addition to real estate legal services, Jakub has also been involved in the establishment of dozens of companies and their corporate changes. In order to provide comprehensive legal services, he has also represented clients in litigation matters, both in contractual disputes and disputes relating to family law and, exceptionally, criminal law.
