Moreover, he has experience in the private sector, having worked as a corporate lawyer at Rossum, a successful Czech AI startup. Jakub has also worked on numerous research projects such as the CyberSecurity, CyberCrime and Critical Information Infrastructures Center of Excellence (C4e). Jakub is a frequent speaker and author of publications, and besides professional forums, he also gave a TEDx Talk in 2023. With Nugis Finem Publishing, he has recently published his own Handbook of Cloud Computing Regulation and co-authored, with a team from PwC, the Practical Commentary on the Data Processing Act.
